

NSSA PAVILION MATERIAL HANDLING PACKAGE

As a NSSA Pavilion exhibitor you may be covered by a basic material handling package.

For StonExpo 2024, all move-in costs will be under the basic NSSA Pavilion package. This package ONLY includes 100% discount off basic in-/out-bound movement of raw material or equipment shipments to and from booth only. Additional fees will apply for forklifts, and any relocation within the booth once initial delivery has been received. It is important to have a company representative in the booth at the time of delivery for correct placement.

A breakdown of the inclusions are as follows:

- C. Informa will cover GSC charges for per-pound material handling charges for NSSA exhibitors at StonExpo 2024. These are international exhibitors from Brazil, Portugal, Italy, Greece and Turkey. *This will not include Xiamen Intop, NSI exhibitors or SESA members who are receiving the material handling credit.*
 - a. Per-pound material handling is defined as the drayage charges assessed by TISE's GSC for items shipped by exhibitors for StonExpo 2024; per-pound drayage charges include the following services:
 - i. Unloading at the dock
 - ii. Movement from dock to booth
 - iii. Initial item positioning inside exhibit space
 - iv. Movement from booth to dock
 - v. Reloading on outbound carrier
 - b. Billing for additional material handling labor and services will be the responsibility of the exhibitor; these services include but are not limited to:
 - i. Re-positioning/spotting of stone slabs or machines
 - ii. Labor to un-crate/un-skid freight
 - iii. Labor to un-tarp/re-tarp open top shipping containers
 - iv. Miscellaneous supplies (Cable Slings, Shackles, Pear Links, Fishing line, etc.)
 - v. Crane labor for oversized/overweight pieces
 - vi. Forklift, scissor-lift, or condor labor required to move items within the booth after initial delivery of freight
 - c. Other charges that are the responsibility of the exhibitor include, but are not limited to:
 - i. Purchased or rented booth display structures & graphics
 - ii. Rental Furniture
 - iii. Carpet / flooring
 - iv. Rigging labor for hanging signs
 - v. Truss / chain motors / lighting
 - vi. Electrical and utilities
 - vii. Cleaning
 - viii. Labor for booth construction and dismantle

It is important to have a company representative in your booth at the time of delivery so that placement is done to your satisfaction.

After unloading your crates be sure to double-check them before placing an "EMPTY" sticker on them. EMPTY stickers can be obtained from the Freeman Service Desk. It is expensive and sometimes

impossible to retrieve an empty container once it has been removed from your booth. For an additional fee, you can order priority crate return service from Freeman. This service provides faster return of empty containers and crates at the close of the show.
