Through this platform, exhibitors will be able to access the full catalogue of available services, review technical specifications, updated prices, and proceed directly with contracting and payment in a fast and secure way. **Orders placed by any other means will not be considered valid.**

GENERAL CONDITIONS OF SERVICE

CONTRACTING AND PAYMENT OF SPACE

The exhibitor must return the duly completed Reservation Form. This document will be valid when it is received signed and sealed.

Once the form is received, the respective invoice will be issued with the payment conditions, leaving the exhibitor subject to all these regulations.

Failure to pay any of these financial contract obligations will entitle the Organization to terminate the contracting of that space request.

Payment conditions: 50% of the total amount of the contracted stand will be upon contract signature and receipt of invoice.

50% of the total amount of the contracted stand will be paid by March 31st 2026. Payment methods: First 50% by Bank transfer. Balance by Ri.Ba.

SPACE/STAND ASSIGNMENT

The assignment of stands will be the exclusive responsibility of the Organization.

STAND MODIFICATIONS, CANCELLATIONS AND TRANSFERS

The Organization reserves the right to modify the schedules of the fair due to force majeure or any other cause, without entitling exhibitors to any type of compensation. Exhibitors may not transfer the right to occupy or allow the promotion of merchandise from other companies in their stands without the written consent of the Organization. Failure to comply with this rule may cause the stand to be closed without the right to any type of compensation.

If you wish to cancel or reduce meters requested in the reservation form, the exhibitor will not have the right to any type of refund.

If the event is cancelled for reasons beyond the control of the organization, the exhibitor will receive the full amount paid up to that point, without the right to any other compensation.

RENT AND PAYMENT OF SERVICES

All exhibitors must install a stand, whether modular or designer.

The contracting of the services described in the Exhibitor's Manual must be carried out through the Stone.gal website, accessing the exhibitor area with the passwords provided by the organizer.

The deadline to rent and pay for the aforementioned services is March 31, 2026 and the assembly of the stand with an outstanding balance will not be permitted. After this date the organizer does not undertake to respond to service requests, it will depend on our availability and possibilities.

All services contracted after this date will have a 50% surcharge on the Exhibitor Manual prices. Any service requested during the assembly or fair must be paid at that time.

VEHICLE ACCESS TO THE IFEVI CAMPUS

Vehicles will not be able to access the interior of the fairgrounds.

It is mandatory to unload the merchandising outside and use, if necessary, a forklift/bulldozer/pallet to carry the merchandise to your stand.

This service must be ordered online on Stone.gal website

Self-unloading: If you have your own means, you must send your request via email, duly completed with all the data to request an unloading appointment, both for assembly and disassembly.

ADVERTISING AT THE EXPO

It is necessary to request a quote and obtain approval from the organization to place any type of advertising outside the stands.

Taking photographs or video of the stands or common areas will not be permitted without prior authorization from the exhibitor or organization.

This prohibition does not affect the media or exhibitors in their own stands.

The organizing team reserves the right to photograph and/or film, by any means, the facilities and stands, as well as the elements exhibited therein and to exclusively use these reproductions in supports, other exhibitions or promotional material of the Expo.

LIABILITY INSURANCE

The company organizing the event is responsible for subscribing to Civil Liability Insurance for material or physical damage to exhibitors, accredited parties and visitors, with a limit pending to be defined according to the dates of the event.

Coverage includes exploitation, legal defense and criminal bail.

Any other type of insurance will be the exclusive responsibility of the exhibitor.

CLEANING OF THE STANDS

The organization team will supervise the general cleaning of the Fairgrounds (common spaces).

- Stonegal Stands: The first cleaning of these stands is automatically included in the contract, but not their maintenance, which must be requested separately, according to the rate.

- Design stands: The first cleaning and/or maintenance of these stands must be requested, if necessary, all according to the rates displayed in the Exhibitor Area.

SECURITY

Stone.gal guarantees general surveillance services during the assembly, celebration and dismantling periods of the event. However, exhibitors are responsible for the care of their materials and products. If they would like to reinforce the surveillance of their stands, they will only be able to hire personnel through the company that provides these services to Stone.gal.

All exhibitors and assembly/disassembly personnel must have their passes visible. The presence of exhibitors at their stand during fair hours is recommended, with emphasis on the

last day of the event. Starting at 6:00 p.m., exhibitors can and must remove easily removable merchandise or material, in order to avoid possible theft.

SMOKES AND GASES

Any gas or vapor produced by the exhibited material that may be harmful to health or cause any type of damage must be evacuated through appropriate ducts.

The installation of said ducts requires authorization from the Technical Organization Department.

STONEGAL STANDS

It is not necessary to pay an assembly/disassembly fee or an electrical installation supervision bulletin.

It is prohibited to damage or perforate the panels and furniture. In case of damage, the exhibitor will assume the replacement cost.

Any other provision will be subject to coordination by the event organization.

INFORMATION AS PER ARTICLE 13 OF EUROPEAN REGULATION N. 2016/679 (GENERAL DATA PROTECTION REGULATION – GDPR)

1. Handling modes

The data you communicate will be treated by the handler in print, by computer or telecommunicated.

2. Treatment purposes

Your personal data will be treated in conformity with what is prescribed by article 6, clause 1, section b) of the GDPR for the following purposes:

- Provision of the services requested (sales of tradeshow space and/or ads in the technical magazine Marmomacchine International)
- Administrative purposes (for orders, estimates, invoicing, etc.).

Your data will be treated by means of the operations indicated in article 4, clause 1, n. 2) of the GDPR and specifically: collection, registration, organization, conservation, consultation, processing, modification, selection, extraction, comparison, utilization, interconnection, blockage, communication and destruction of data. Your personal data are treated in print, electronically and automatically.

3. Conservation

The personal data conferred for the aforesaid purposes will be conserved for the duration of the contract and until termination of collaboration.

4. Access to personal data

Your data may be accessed for the aforesaid purposes by:

- employees and collaborators of the handler, as designated persons
- external persons for accounting, tax and payment purposes
- suppliers, technicians involved with hardware and software that outsource on behalf of the handler
- consultancy firms utilized by the handler.

5. Data communication

The personal data thus collected will not be communicated to third parties except for those working in data treatment (i.e. graphic designers working on the magazine, tradeshow, etc.)

6. Data transmission

Personal data management and conservation will make use of servers located within the European Union.

The data will not be transmitted outside the European Union. It is in any case understood that, where necessary, the handler will have the right to move the location of the servers in Italy and/or the European Union and/or countries outside the EU. In this case, the handler henceforth ensures that data transmission outside the European Union will be in conformity with the applicable laws, if necessary stipulating agreements that guarantee a suitable level of protection and/or adopting the standard clauses foreseen by the European Commission.

7. Type of data conferral and consequences of refusal

Conferring data for the purposes set down in point 1 is obligatory. If refused, we cannot ensure the correct management of contractual relations.

8. Rights of the person concerned

As the person concerned, you have rights as per article 15 of the GDPR and specifically the right to:

- obtain confirmation of the existence, or lack thereof, of the personal data that concerns you;
- obtain knowledge: a) of the origin of this personal data; b) the purposes and modes of its treatment; c) the means involved in the case of treatment using electronic instruments; d) the identification of the handler, managers and designated representative as per article 3, clause 1 of the GDPR; e) the persons or category of persons to whom personal data may be communicated or that may gain knowledge of it as designated representative of the state, of managers of employees;
- obtain: a) data updates, rectifications or, when you are interested, data supplements; b) cancellation, transformation into anonymity or block of the data treated in violation of laws, including the data whose conservation is not required in relation to the purposes for which the data was collected or subsequently treated; c) an attestation that the operations in letters a) and b) were brought to the knowledge, even in regard to content, of persons to whom the data was communicated or spread, except when fulfillment of this involves the use of means clearly disproportionate to the protected right;
- oppose, wholly or in part: a) for legitimate reasons, treatment of your personal data, even though pertinent to the purposes of collection; b) treatment of your personal data for the purposes of sending publicity material or direct sales or to perform market research or business communication. Where applicable, you also have the rights set down in articles 16 to 21 of the GDPR (to rectify, to consign to oblivion, to limit treatment, to transfer contractual and raw navigation data, to oppose treatment) as well as the right to complain to the oversight authorities.

9. How to exercise your rights

You may at any time exercise your rights by sending an email, fax or registered letter with delivery receipt to the handler's address.

10. Handler, manager and persons charged

The data handler is MARMOMACCHINE SERVIZI Srl, Corso Sempione 30, Milan (MI), VAT registration and Tax Code 12574150152. A current list of data treatment managers (where designated) and persons charged with data treatment is kept on the handler's premises.
